5. CORRESPONDENCE

Director Giammarese went over the Order of Suspension with the Commissioners. He stated that the Village Administrator, Peter Scalera had the final decision in the suspension and he reduced the suspension from 50 hours to 30 hours to be served during February and March 2019.

Sergeant Exam: Current list expires on April 20, 2019. A letter of interest went out to all officers that qualify to participate in the Sergeant Promotional Assessment Center. There are 19 prospective candidates. Director Giammarese expressed that he believe several of the potential candidates will not be participating in the process due to a variety of reasons. Some feel they are too new; at the end of their careers; or simply just don't have an interest in becoming a supervisor.

New Officer Police Test: Application process closed. The Orientation and Written Test was held on Saturday, February 9<sup>th</sup>. There were 161 applications returned; 131 candidates took the test. There are 42 candidates that will move onto the physical agility test on Saturday, March 2, 2019. The test will take place at Glenbard North High School at 3:00 p.m.

Director Giammarese felt the Orientation was successful and that we had a good turnout for the day. He stated that he was proud of the turnout of not only candidates that attended, but the large number of Bloomingdale Officers that chose to attend the Orientation. He also informed that Commissioners that one of the candidates is Deputy Chief Tim Roberts' son, Michael Roberts. If the candidate successfully passes the Physical Fitness Test, in order to alleviate any issues that may arise by having a Detective conduct the Background Investigation, he determined it would be best to have Watch Commander Krueger conduct the Investigation.
