**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE,
AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS);
CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES)
TO INCREASE THE NUMBER OF CLASS “MW” MICRO-WINDERY LICENSES,
MAHAN WINES LLC, 103 FESSLER DRIVE**

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois (the “Village”) is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, Mahan Wines LLC (103 Fessler Dr.) applied for a Class “MW” (Micro-Winery) Village liquor license, to operate a micro-winery establishment and

WHEREAS, the establishment has satisfied both the Village and State of Illinois conditions for operating a micro-winery.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: Title 4 (Business and License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to increase the number of Class “MW” licenses by one (1), resulting in a final count of one (1) total Class “MW” liquor licenses.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
