**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE,
AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS);
CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES)
TO DECREASE THE NUMBER OF CLASS D-1 (BEER & WINE) LIQUOR LICENSES AND
INCREASE THE NUMBER OF CLASS D-2 (FULL LIQUOR) AND CLASS "V" (VIDEO
GAMING) LIQUOR LICENSES, HMTL LLC (D.B.A. PHO LICIOUS)**

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois (the "Village") is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, HMTL LLC, D.B.A. Pho Licious (369 W. Army Trail Rd) applied to close their current Class D-1 (Beer & Wine) Liquor License in order to be replace it with a Class D-2 (Full Liquor) and a Class "V" (Video Gaming) Village liquor license, to operate video gaming terminals in their restaurant establishment, and

WHEREAS, the restaurant establishment has satisfied both the Village and State of Illinois conditions for operating video gaming terminals.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: Title 4 (Business and License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to decrease the number of Class D-1 liquor license by one, and increasing the number of Class "D-2" and Class "V" liquor licenses by one (1), resulting in a final total count of five (5) Class D-1, six (6) Class D-2 and nine (9) Class "V" liquor licenses.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
