**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE,
AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS);
CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES)
TO INCREASE THE NUMBER OF CLASS "P-2" LIQUOR LICENSES,
HAZELTONS LLC, D/B/A/ HAZELTONS, 360 W. ARMY TRAIL RD**

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois (the "Village") is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, Hazeltons LLC desires to operate a Gourmet store with gourmet food, flowers and gift baskets with wine and liquor, for sale both online and at their new Hazeltons store at 360 W. Army Trail Rd; and

WHEREAS, the sale of wine and liquor is not incidental and the total store floor area devoted to liquor sales exceeds 10%,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: Title 4 (Business and License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to increase to the number of Class P-2 liquor license by one (1), resulting in the maintenance of four (4) total Class P-2 liquor licenses.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
