**ORDINANCE NO. 2021-08**

**AN ORDINANCE ABATING THE BOND ORDER FOR SERIES 2020B LEVY OF TAX AUTHORIZED BY ORDINANCE NO. 2020-31 AN ORDINANCE AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$14,050,000 GENERAL OBLIGATION BONDS, SERIES 2020, OF THE VILLAGE OF BLOOMINGDALE, ILLINOIS**

**WHEREAS**, the Village of Bloomingdale, DuPage County, Illinois (hereinafter referred to as the “Village”) is a home rule unit of local government, and as such may exercise any power and perform any function pertaining to its government and affairs, except as limited by Article VII, Section 6 of the 1970 Illinois Constitution; and

**WHEREAS**, the President and Board of Trustees, by Ordinance No. 2020-31 adopted on November 9, 2020, did issue tax-exempt General Obligation Bonds, Series 2020B bonds (the "Bonds"), in the amount of \$4,220,000 for the purpose of refunding the Waterworks and Sewerage Fund’s Illinois Environmental Protection Agency loan number L17-2246; and

**WHEREAS**, Ordinance No. 2020-31 authorized a direct annual tax to be levied upon all the taxable property within the Village for the payment of Bonds; and

**WHEREAS**, the tax levy requirement so authorized for the year 2020 to be collected in 2021 to pay principal and interest on the Bonds up to and including April 30, 2022, is \$724,913.33; and

**WHEREAS**, the President and Board of Trustees, has determined that there is, or will be, excess and sufficient funds available, or to be made available, in the Waterworks and Sewerage Fund to abate \$724,913.33 of the required tax levy; and

**WHEREAS**, this ordinance represents an exercise of the home rule powers conferred upon the Village by the Constitution of the State of Illinois.

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF BLOOMINDALE, DUPAGE COUNTY, ILLINOIS**, as follows:

**Section One:** The foregoing recitals shall be, and are hereby, incorporated into and made a part of this Ordinance as the findings of the Village Board.

**Section Two:** The Village Treasurer be, and is hereby directed to set aside or be so set aside \$724,913.33 from excess funds available or to be made available in the Waterworks and Sewerage Fund, for which said funds are to be used to satisfy the 2020 tax levy requirement necessary to retire the Bonds and to hold said funds solely for such purpose.

**Section Three:** The Village Treasurer be, and is hereby directed to pay \$724,913.33 from funds on hand or to be on hand in the Waterworks and Sewerage Fund, to retire the Bonds as said become due and payable.

**Section Four:** That the County Clerk of DuPage County be and he is hereby authorized and directed to abate the amount of \$724,913.33 from the 2020 Village tax levy for which said tax levy is for the payment of principal and interest up to and including April 30, 2022 for the tax-exempt General Obligation Bonds, Series 2020B, approved November 9, 2020.


**Section Five:** That the Village Clerk is hereby authorized and directed to file a certified copy of this ordinance with the County Clerk of DuPage County, Illinois.

**Section Six:** This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
