**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE,
AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS);
CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES)
TO INCREASE THE NUMBER OF CLASS "V" VIDEO-GAMING LICENSES,
MANDARIN BISTRO INC. AND ALCENTRO TRATTORIA, LLC**

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois (the "Village") is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, Mandarin Bistro Inc. (156B E Lake Street) and Alcentro Trattoria, LLC. (109 3rd Street) both submitted applications for a Class "V" (Video Gaming) supplemental Village liquor license, to operate video gaming terminals in their restaurant establishments and

WHEREAS, both restaurant establishments have satisfied both the Village and State of Illinois conditions for operating video gaming terminals.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: Title 4 (Business And License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to increase the number of Class "V" supplemental liquor licenses by two (2), resulting in a final count of eight (8) total Class "V" supplemental liquor licenses.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
