**ORDINANCE NO. 2020-19**

**AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO DECREASE THE NUMBER OF CLASS "D-2" LIQUOR LICENSES, (ERJ DINING IV,LLC D.B.A. CHILI'S GRILL & BAR), AND INCREASE THE NUMBER OF CLASS "D-2" LIQUOR LICENSES (BRINKER RESTAURANT CORPORATION, D.B.A. CHILI'S GRILL & BAR), 310 W. ARMY TRAIL ROAD**

**WHEREAS**, the Village of Bloomingdale, DuPage County, Illinois (the "Village") is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, ERJ DINING IV,LLC D.B.A. CHILI'S GRILL & BAR; is the current franchisee of the Chili's Grill & Bar at 310 W. Army Trail Road, and

**WHEREAS**, and Brinker Restaurant Corporation, is the owner of Chili's Grill & Bar, and has taken over the operation of the Chili's Grill & Bar, 310 W. Army Trail Road.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:**


**SECTION 1:** Title 4 (Business and License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to decrease the number of Class D-2 liquor licenses by one (1), followed by an increase to the number of Class D-2 liquor license by one, resulting in the maintenance of twenty-two (22) total Class D-2 liquor licenses.

**SECTION 2:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
