ORDINANCE NO. 2019-13

AN ORDINANCE AMENDING THE BLOOMINGDALE VILLAGE CODE, AS AMENDED, TITLE 4 (BUSINESS AND LICENSE REGULATIONS); CHAPTER 2 (ALCOHOLIC BEVERAGES); SECTION 10 (NUMBER OF LICENSES) TO DECREASE THE NUMBER OF CLASS "P-3" LIQUOR LICENSES, DIYA FOODS, INC. (D.B.A. HOMETOWN PANTRY), AND THEN INCREASE THE NUMBER OF CLASS "P-3" LIQUOR LICENSES, SURREY ENTERPRISES, INC. (D.B.A. HOMETOWN PANTRY)

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois (the "Village") is a home rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, DIYA Foods, Inc. has signed their lease for the Hometown Pantry, 360 Schick Rd., Unit 24, over to Surrey Enterprises, Inc., thereby surrendering their Class P-3 (Packaged Beer & Wine Incidental Sales) Village liquor license, and

WHEREAS, Surrey Enterprises, Inc. has signed the lease for 360 Schick Rd., Unit 24, to operate under the same D.B.A name (Hometown Pantry); and have requested the issuance of a new Class P-3 (Packaged Beer & Wine Incidental Sales) Village liquor license.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF BLOOMINGDALE, DUPAGE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

SECTION 1: Title 4 (Business And License Regulations); Chapter 2 (Alcoholic Beverages); Section 10 (Number of Licenses) of the Bloomingdale Village Code is hereby amended, as set forth on the attached Exhibit A, to decrease the number of Class P-3 liquor licenses by one (1), and then increase the number of Class P-3 liquor licenses by one (1), resulting in the maintenance of one (1) Class P-3 liquor license.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
