**A RESOLUTION
APPROVING AND AUTHORIZING THE EXECUTION OF THE FY2024 (2023-2024
SNOW SEASON) DUPAGE COUNTY JOINT PURCHASING REQUISITION FOR
SODIUM CHLORIDE (ROCK SALT)**

WHEREAS, the Village of Bloomingdale (hereinafter referred to as the "Village") is a home rule unit of local government with authority granted pursuant to the Illinois Constitution of 1970, to exercise certain powers and perform certain functions pertaining to its local government and affairs;

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt;

WHEREAS, Article VII, Section 10 of the Illinois Constitution of 1971 and the Illinois Intergovernmental Cooperation Act 5 ILCS 220/1, et seq., allow units of local government to enter into intergovernmental agreements in the furtherance of their governmental purposes;

WHEREAS, Village Staff recommends the Village President and Board of Trustees ("Corporate Authorities") to authorize the execution of the FY2024 (2023-2024 Snow Season) DuPage County Joint Purchasing Requisition for Sodium Chloride (Rock Salt) (the "Joint Purchasing Requisition"), attached hereto and incorporated herein as Exhibit A, to purchase base amount of 1,300 tons with the guarantee minimum amount of 1,040 tons (80%) with the option to purchase up to 1,650 tons (130%);

WHEREAS, the Village has participated in this program previously and it has proven to be a reliable and cost effective source for the procurement of rock salt; and

WHEREAS, the Corporate Authorities of the Village of Bloomingdale are of the opinion that the foregoing actions are in the best interest of the public safety, health and welfare of the residents of the Village of Bloomingdale.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois as follows:

Section One – Recitals

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to the Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section Two –Approval of Agreement

The Village hereby approves the execution of the Joint Purchasing Requisition substantially in the form attached hereto and made a part hereof as Exhibit A.

Section Three – Authorization and Direction

The Village President and/or Village Administrator is hereby authorized to execute, and the Village Clerk is hereby authorized to attest to the Joint Purchasing Requisition, substantially in the form attached hereto as Exhibit A.

Section Four -- Other Actions Authorized

The officers, employees and/or agents of the Village shall take all actions necessary or reasonably required to carry out and give effect to the intent of the Joint Purchasing Requisition and otherwise to consummate the transactions contemplated therein, and shall take all actions necessary in conformity therewith including, without limitation, the execution and delivery of all documents required to be delivered in connection with the transaction contemplated herein.

Section Five – Authorization of Expenditures

The Corporate Authorities hereby authorize and direct the expenditure of all costs related to the execution of the Joint Purchasing Requisition to participate in the FY2024 program.

Section Six - Acts of Village Officials

That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of the Agreement are hereby, in all respects, ratified, approved, authorized and confirmed.

Section Seven – Effective Date

This Resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section Eight – Publication

This Resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Nine – Conflict Clause

All resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section Ten – Saving Clause

If any section, paragraph, clause or provision of this Resolution is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this Resolution, which are hereby declared to be separable.

Section Eleven – Recording

This Resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
