**A RESOLUTION
APPROVING AND AUTHORIZING THE EXECUTION OF PURCHASE ORDER FOR
OPERATING EXPENSES FOR THE POLICE DEPARTMENT; DUPAGE JUSTICE
INFORMATION SYSTEM AND POLICE RECORDS MANAGEMENT SYSTEM**

WHEREAS, the Village of Bloomingdale (hereinafter referred to as the "Village") is a home rule unit of local government with authority granted pursuant to the Illinois Constitution of 1970, to exercise certain powers and perform certain functions pertaining to its local government and affairs;

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt;

WHEREAS, Article VII, Section 10 of the Illinois Constitution of 1971 and the Illinois Intergovernmental Cooperation Act 5 ILCS 220/1, et seq., allow units of local government to enter into intergovernmental agreements in the furtherance of their governmental purposes;

WHEREAS, in 2017 the Village of Bloomingdale entered into an Intergovernmental Agreement with DuPage County to participate in a county-wide Report Management System (RMS) that has allowed for easier exchange of information with the State's Attorney's Office, Corrections Department and other municipal Police Departments;

WHEREAS, Village Staff recommends the Village President and Board of Trustees ("Corporate Authorities") approve the attached Purchase Order in the amount of \$47,242.06 DuPage County for operating expenses for utilization of the RMS System for the upcoming year;

WHEREAS, the participating in the program has been cost effective due to the reduction in cost of owning and operating the entire system, the enhanced operating efficiencies; and improved level of service as a result of the sharing of information between all agencies participating in the program; and

WHEREAS, the Corporate Authorities of the Village of Bloomingdale are of the opinion that the foregoing actions are in the best interest of the public safety, health and welfare of the residents of the Village of Bloomingdale.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois as follows:

Section One – Recitals

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to the Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section Two –Approval of Purchase Order

The Village hereby approves the Purchase Order in the form attached hereto and made a part hereof as Exhibit A.

Section Three -- Other Actions Authorized

The officers, employees and/or agents of the Village shall take all actions necessary or reasonably required to carry out and give effect to the intent of the Purchase Order and otherwise to consummate the transactions contemplated therein, and shall take all actions necessary in conformity therewith including, without limitation, the execution and delivery of all documents required to be delivered in connection with the transaction contemplated herein.

Section Four – Authorization of Expenditures

The Corporate Authorities hereby authorize and direct the expenditure of all costs related to the execution of the Purchase Order.

Section Five - Acts of Village Officials

That all past, present and future acts and doings of the officials of the Village that are in conformity with the purpose and intent of the Agreement are hereby, in all respects, ratified, approved, authorized and confirmed.

Section Six – Effective Date

This Resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section Seven – Publication

This Resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Eight – Conflict Clause

All resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section Nine – Saving Clause

If any section, paragraph, clause or provision of this Resolution is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this Resolution, which are hereby declared to be separable.

Section Ten – Recording


This Resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
