**A RESOLUTION
APPROVING A GRANT REQUEST FROM
THE BLOOMINGDALE LIGHTNING FC SOCCER CLUB
IN ACCORDANCE WITH
THE VILLAGE OF BLOOMINGDALE COMMUNITY GRANT PROGRAM**

WHEREAS, the Village of Bloomingdale, DuPage County, Illinois is a home rule unit of local government, and as such may exercise any power and perform any function pertaining to its government and affairs, except as limited by Article VII, Section 6 of the 1970 Illinois Constitution;

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt;

WHEREAS, in 2017 the Village Board created a Community Grant Program to aid Bloomingdale organizations needing support with extraordinary expenses to individual programs;

WHEREAS, Village Staff presented a grant request (the "Grant Request") from the Bloomingdale Lightning FC Soccer Club ("BLFC"), attached hereto and incorporated herein as Exhibit A, for review and discussion at the April 10, 2023 Standing Committee of the Whole Meeting of the President and Board of Trustees of the Village of Bloomingdale;

WHEREAS, BLFC is a non-profit competitive youth travel soccer program located in the Village of Bloomingdale maintain the mission of helping to develop players to be competitive at the highest level of youth soccer through providing a positive learning environment and focusing on strong core fundamentals;

WHEREAS, Village Staff recommends approval of the Grant Request from BLFC in the amount of \$5,000 for Fiscal Year 2023; and

WHEREAS, the Corporate Authorities of the Village of Bloomingdale are of the opinion that it is in the best interests of the health, welfare and safety of the residents of the Village of Bloomingdale to approve and award the Grant Request to BLFC as provided for herein.

NOW, THEREFORE, BE IT RESOLVED by the Village President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois pursuant to the Village of Bloomingdale's "Home Rule Powers" as follows:

Section One – Recitals

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to this resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this resolution as legislative findings.

Section Two – Approval of Grant

The Corporate Authorities hereby approve and award the Grant Request in the amount of \$5,000, attached hereto and incorporated herein as Exhibit A, to BLFC.

Section Three – Effective Date:

This resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section Four - Publication

This resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Five - Recording


This resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
