**RESOLUTION NO. 2022-R-34**

**A RESOLUTION ESTABLISHING  
REGULAR BOARD MEETING DATES AND TIMES  
FOR CALENDAR YEAR 2023**

**WHEREAS**, the Village of Bloomingdale is a home rule unit of local government with authority granted pursuant to the Illinois Constitution of 1970, to exercise certain powers and perform certain functions pertaining to its local government and affairs;

**WHEREAS**, Section 2.02(a) of the Open Meetings Act, 5 ILCS 120/2.02(a) requires that every public entity shall give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year;

**WHEREAS**, Section 2.02(a) of the Meetings Act also requires the Village to set the regular dates, times and places of such meetings;

**WHEREAS**, it is the intention of the Village Board of the Village of Bloomingdale to comply with the Open Meetings Act; and

**WHEREAS**, the Village of Bloomingdale Corporate Authorities, by and through this Resolution, hereby set the schedule of the regular meetings that will be held by the Village along with the respective dates, times and places of such meetings for calendar year 2023.

**NOW, THEREFORE, BE IT RESOLVED** by the Village President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois pursuant to the Village of Bloomingdale's "Home Rule Powers" as follows:

**Section One - Recitals**

The Corporate Authorities hereby find that all the recitals hereinbefore stated as contained in the preamble to this Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

**Section Two – Dates and Times of Meetings of Village Board of Trustees**

The Village Board of the Village of Bloomingdale shall hold meetings of the Standing Committee of a Whole at 6:00 p.m. on the second and fourth Monday of every month and hold meetings of the Village Board at 7:00 p.m. The scheduled meeting dates are contained in Exhibit A which is attached hereto and made a part hereof.

**Section Three – Meetings of Village Boards and Commissions**

The Planning Board, Zoning Board of Appeals, Pension Board and Board of Fire and Police Commissioners shall hold regular meetings, scheduled meeting dates are contained in Exhibit A which is attached hereto and made a part hereof.

**Section Four – Place of Meetings**

Meetings will be conducted in the Board Room of the Bloomingdale Village Hall, 201 S. Bloomingdale Road, Bloomingdale, Illinois, 60108.

**Section Five – Meetings Open to the Public**

All meetings are open to attendance by the public.

**Section Six – Cancelation, Rescheduling and Change of Meeting Dates and Times**

Nothing in the Resolution shall be construed to prevent the Village Board from canceling a regular meeting or changing the date, time or location of any regular meeting, provided that notice of the changed date, time or location will be provided in accordance with all applicable provisions of the Open Meetings Act.

**Section Seven – Effective Date**

This Resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

**Section Eight - Publication**

This Resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

**Section Nine – Conflict Clause**

All Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**Section Ten – Saving Clause**

If any section, paragraph, clause or provision of this Resolution is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this Resolution, which are hereby declared to be separable.

**Section Eleven – Recording**

This Resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
