**A RESOLUTION APPOINTING
A DELEGATE AND ALTERNATE DELEGATE
TO THE INTERGOVERNMENTAL RISK MANAGEMENT AGENCY (IRMA)**

WHEREAS, the Village of Bloomingdale (hereinafter referred to as "Village") is a home rule unit of local government with authority granted pursuant to the Illinois Constitution of 1970, to exercise certain powers and perform certain functions pertaining to its local government and affairs;

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt;

WHEREAS, the Village of Bloomingdale is a member of the Intergovernmental Risk Management Agency (IRMA); and

WHEREAS, the Contract and Bylaws of IRMA provides that member units of local government shall by majority vote of its corporate authorities select a Delegate and an Alternate to represent the Village of Bloomingdale on the Board of Directors of said Intergovernmental Agency;

BE IT RESOLVED by the CORPORATE AUTHORITIES, of the Village of Bloomingdale, DuPage County, Illinois, as follows:

Section 1. Kaitlyn Buggy, Assistant Village Administrator/Director of Human Resources, of the Village of Bloomingdale, is hereby appointed as delegate to represent the Village of Bloomingdale on the Board of Directors of said Intergovernmental Risk Management Agency.

Section 2. Victoria Montbriand, Interim Finance Director, of the Village of Bloomingdale, is hereby appointed as the alternate delegate to serve if the delegate is unable to carry out his/her aforesaid duties as the representative of the Village of Bloomingdale to said Intergovernmental Agency.

NOW, THEREFORE, BE IT ORDAINED, in open meeting assembled by the Village President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois pursuant to its home rule powers as follows:

Section One – Recitals

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preamble to this Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

Section Two - Effective Date:

This resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

Section Three - Publication

This resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

Section Four - Conflict Clause

That all resolutions, parts of resolutions or board actions in conflict with the terms of this resolution shall be repealed to the extent of said conflict.

Section Five - Recording

This Resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
