**RESOLUTION NO. 2021 – R-15**

**RESOLUTION AUTHORIZING THE VILLAGE PRESIDENT TO ENTER INTO A CONTRACT AGREEMENT WITH MAD BOMBER FIREWORKS PRODUCTIONS OF KINGSBURY, INDIANA AS THE VENDOR AND DISPLAY OPERATOR FOR THE 2021 BLOOMINGDALE FIREWORKS DISPLAY IN AMOUNT OF \$38,800**

**WHEREAS**, the Village of Bloomingdale, DuPage County, Illinois (the “Village”) is a home rule unit of local government pursuant to Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the Village reinstated the Fireworks Display in 2016 and the event has become a resident favorite and helped build a sense of community as families come together to enjoy the show; and

**WHEREAS**, Fireworks Display will be held on September 10, 2021 at the open space of the former Indian Lakes golf course and the Village will be using the services of Mad Bomber Fireworks Productions a licensed pyrotechnic display company,

**NOW THEREFORE BE IT RESOLVED** by the President and Board of Trustees of the Village of Bloomingdale, DuPage County, Illinois, as follows:

**SECTION 1.** That the Village President execute the Service Agreement in substantially the form attached hereto as Exhibit "A".

**SECTION 2.** That this Resolution shall be in full force and effect after its passage and approval as required by law.

**SECTION 3.** This Resolution shall be in full force and effect from and after its passage, approval and publication as provided by law.

**SECTION 4.** This Resolution shall be published in book or pamphlet form as provided by the Illinois Municipal Code.

**SECTION 5.** All resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 6.** If any section, paragraph, clause or provision of this Resolution is declared by a court of law to be invalid or unconstitutional, the invalidity or unconstitutionality thereof shall not affect the validity of any other provisions of this Resolution, which are hereby declared to be separable.

**SECTION 7.** This Resolution shall be entered into the minutes and upon the journals of the Board of Trustees of the Village of Bloomingdale.
